Payment Requirements:

50% deposit due by June 30, 2022 to maintain your reserved booth location
50% due by November 15, 2022 to secure your space with full payment

Priority Placement:

All Pre-Sale contracts submitted will be time and date stamped. SPESA members will be placed first in priority order. Thereafter, non-members will be placed first come, first served.

SPESA Member Priority Placement

All SPESA members are welcome to rebook exhibit space during Pre-Sales and can come by the Sales Office at any point during the show. When submitting your contract, it will be time and date stamped and your booth will later be assigned based on priority status.

Order of Placement:

Tier 1	Placed by individual priority, with scheduled appointment
Tiers 2-5	Placed next in tier order, based on time and date received
Non-Members	Placed by time and date received

SPESA Member Pre-Sale rates will be valid through May 26, 2022, however we encourage all to submit a contract onsite for priority placement over the others in your tier.

SPESA members who do not book during Pre-Sales will forego their priority for placement and will reserve space based on availability thereafter with general sales.
